



One-Year Limited Labor Warranty

VINYL SIDING, SOFFIT & FASCIA WARRANTY INFORMATION

The Third Estimate Corporation will repair defects that may arise with their new vinyl siding and/or soffit and fascia that was a direct result of faulty or incomplete installation of the vinyl siding, soffit, and fascia at no cost to the original purchaser of the product for one year from the date of completion of installation.

Any claims for defects under this warranty must be submitted in writing to The Third Estimate Corporation at 30500 Solon Industrial Parkway, Solon, Ohio 44139, within the warranty period and promptly after discovery of the claim defect, describing the defect and a picture of the defect. If after inspection, The Third Estimate Corporation determines that the claim is valid in accordance with the terms of this warranty, The Third Estimate Corporation agrees, as its sole option, to repair, refinish or replace the damaged area affected by any faulty or incomplete installation. The obligation of The Third Estimate Corporation under this warranty shall be performed only by persons designated and compensated by The Third Estimate Corporation for that purpose and is subjected to all other provisions of this warranty.

The original warranty period shall not be extended by any such work performed, but the remaining warranty time period shall continue in effect and be applicable under the terms and conditions of this warranty to the warranty work performed. The Third Estimate Corporation reserves the right to discontinue or change any material originally used on original installation. If any material originally installed is not available and The Third Estimate Corporation determines it needs to be replaced, The Third Estimate Corporation shall have the right to substitute a part or material of equal quality.

The Third Estimate does not warranty the vinyl siding and/or soffit, and fascia for manufacturing defects. This warranty does not cover any other damages, including but not limited to normal weathering, oxidation, acts of God, fire, flood, wind, windblown objects, chemical pollutants, structural defects, negligent maintenance, or abuse.

If a service is requested after the one-year labor warranty expires, a \$150 trip charge applies for us to come out to the home. At that time, our representative will address the issue/s, give the homeowner a description of needed repairs and an estimate, including labor and materials.

The provisions of this warranty are the full and complete warranty policy extended by The Third Estimate Corporation.

The warranty shall remain in effect only if normal cleaning practices are performed for maintenance of the vinyl siding and/or soffit and fascia. This warranty will be null and void if the vinyl siding and/or soffit and fascia has been physically altered by anyone other than persons authorized by The Third Estimate Corporation or if harmful cleaning compounds are used.

This warranty is only for services that have been paid in full.
